RE: CRITICAL NOTICE - LAT-LON HARDWARE DEVICE AND WEB PLATFORM SHUTDOWN

As a valued customer of Lat-Lon, L.L.C., a Colorado limited liability company (collectively, "we", "our", "Lat-Lon"), we are writing to notify you that we have made the difficult decision to discontinue all Lat-Lon asset tracking hardware devices ("Lat-Lon Hardware") and the Lat-Lon web portal ("Lat-Lon Platform", and together with Lat-Lon Hardware, "Lat-Lon Products").

All Lat-Lon Products will be discontinued as of DECEMBER 31, 2025 (the "Lat-Lon Shutdown Date").

The Lat-Lon Products include:

- LMU (Locomotive Monitoring Unit)
- STU (Solar Tracking Unit)
- MiniSTU (Mini Solar Tracking Unit)
- CTU (Compact Tracking Unit)
- All Wireless Sensors (x100 & x200 models)

Impact on your Lat-Lon Products:

As of the Lat-Lon Shutdown Date, the following will take place:

- Any and all contracts, orders, or agreements (as amended, renewed, extended, supplemented, replaced
 or otherwise modified from time to time in accordance with the provisions thereof, including any
 Statement of Works included therein) will terminate and be of no further force or effect; and
- Your Lat-Lon Hardware be deactivated and cease to function. No data will be transmitted to the Lat-Lon Platform.

Access to the Lat-Lon Platform:

- You will be allowed to access the Lat-Lon portal for 60 days past the Lat-Lon Shutdown Date; and
- Access to the Lat-Lon data portal will be removed as of March 2, 2026. Please use that time to save the data that you need.

Lat-Lon Platform Data Retrieval

If you would like a csv copy of your Lat-Lon Hardware data, please email the Lat-Lon support team at supportlat-lon@geotab.com by **December 1, 2025** to submit a request. Requests will be handled in as timely a manner as reasonably possible.

As appropriate, we encourage you to dispose of any Lat-Lon Hardware in accordance with your local laws and regulations and in an environmentally-friendly manner.
